Supportive Services for Veteran Families (SSVF)

The goal of the Supportive Services for Veterans Families (SSVF) Program is to help Veteran families who are homeless, or at risk of homelessness, to quickly gain stability in permanent housing.

To be eligible for SSVF Services individuals/ families must meet specific program criteria which include:

- "Veteran" Household Status: Applicant households must either be a Veteran or a member of a family in which the head of household, or the spouse of the head of household, is a Veteran.
- ·Very low-income
- •Imminently at-risk of literal homelessness
- •Meet SSVF "But For" Rule: Applicant's must have no other/additional resources, or subsequent housing options.



A pre-screening will be conducted on all applicants to determine if individuals/families meet basic eligibility requirements for SSVF Program.



SSVF Services

Services may vary based on need/eligibility of veteran families.

- √ Case management services (housing searches, needs assessments, housing stability planning, assistance securing permanent housing)
- √ Assistance obtaining/coordinating VA benefits
- ✓ Referrals for Job Training/Education Service, legal services, financial management classes, health services, and other community services

- √ Assistance obtaining/coordinating other public benefits, and community referrals
- √ Temporary Financial Assistance payable to third parties for eligible expenses (rental assistance, deposits, utilities assistance, childcare, transportation/bus passes)
- ✓ Outreach Services

The SSVF Program is VA funded, no fees are necessary
